Mr. Bowen moved that the LNC disburse funds in the amount of \$15,000 to the Libertarian Party of Illinois for ballot access use when 12,500 signatures have been secured and an additional \$15,000 upon reaching 28,750 signatures (115% of the minimum threshold).³

The Libertarian Party of Missouri has secured an agreement with an attorney who would cap the case at \$15,000 for which they have \$5,000 committed if the LNC would contribute up to \$10,000. LNC Leadership,

My name is Steve Suess. I'm the Chair of LP Illinois. After speaking with a handful of you at convention, I'm writing today to make a request for ballot access funding in Illinois. A detailed account of our current situation is below. Should you need any additional information or have any questions, please don't hesitate to write back or call me.

Current Status

The Libertarian statewide slate in Illinois needs 25,000 minimum valid signatures to get on the November 2022 General Election ballot. Knowing that Republican and Democrat lawyers are waiting to try and throw us off with signature challenges, our original goal was 40,000 gross signatures. Our turn-in deadline is Monday July 11, 2022, making the last day of collection Sunday July 10. The attached spreadsheet shows the status of the petition drive, as of Wed, June 1.

What We've Already Contributed

There is a very good volunteer effort underway that may generate 17,500 volunteer signatures, and we think we have lined up sufficient paid petitioners to successfully complete this petition drive. At this point in time, LP Illinois already has 6,750 volunteer signatures in hand, with roughly another 5,000 volunteer signatures pledged. Several all-star petitioners have also set a goal at 5,300 excess signatures past their original pledge. Assuming volunteers continue to make good progress, we should hit this 17,500 volunteer signature mark. We hope to generate more, as several of our members within the Mises Caucus are more energized to collect signatures after the convention.

LP Illinois has already contributed a significant amount of money toward ballot access this year. We saved money during FY 21 (\$20,000) to pay for ballot access this year, and budgeted \$9,000 of FY 22 revenue toward ballot access for a total of \$29,000. This is nearly all of our cash available that's not accounted for. To this day, we have spent \$15,500 of our own budget on signatures, and another \$5,000 on a lawsuit in Cook County (Chicago) against a corrupt County Clerk to maintain ballot access for local candidates. That leaves LP Illinois with roughly \$8,500 left of our own budget to spend on signatures this year, which we will certainly exhaust between now and the deadline. Petitioning firms are now asking \$7 per signature in Illinois as gas prices and general inflation continues to plague our society.

The Bill Redpath for Senate campaign has matched LP Illinois spending on signatures, splitting those costs evenly. Some of this money came from a fundraiser the campaign had in April, but there's also a significant amount of Bill's personal wealth that went toward this total.

In total, LP Illinois has collected 5,330 paid signatures. We are ramping up production of paid signatures as we head down the stretch to meet this goal; however, as mentioned earlier, paid signatures are increasingly more expensive to obtain.

Our goal is 18,500 paid signatures, to give us a total of about 35,000 total signatures at turn-in. While this is less than our original goal of 40,000 signatures, we have had a high validity rate with the petitions already turned in, and believe we will survive a ballot challenge with 35,000 gross signatures.

A spreadsheet with signature totals is attached for a more detailed look at our situation.

What We're Asking For

We would like a similar deal to what New York was able to receive from the previous LNC, with money coming as we continue to hit benchmarks. New York was able to get \$15,000 upon hitting 50% of their minimum threshold. With 12,080 signatures on hand right now, we are 420 signatures away from meeting that 50% benchmark. I ask that the LNC contribute \$15,000 to Illinois ballot access either immediately (recognizing that 50% benchmark is going to be fulfilled very shortly), or upon us hitting that goal very soon. New York also was to receive another \$15,000 upon reaching 115% of their minimum threshold. I ask that the LNC match that request to Illinois and contribute another \$15,000 upon reaching

28,750 signatures, 115% of our minimum threshold. We are not seeking special treatment, just simply the same deal New York received for their ballot access drive.

Why this Matters

For starters, this is the best shot Illinois has had at statewide ballot access since I have joined the party, and potentially, in my entire lifetime. The current Secretary of State in Illinois is named Jesse White. He has been in office since 1998. His name is plastered everywhere in Illinois (on court documents, our Driver's Licenses, etc.) and is well-known throughout the state. He even has his own gymnastics team (The Jesse White Tumblers) that go around the state doing halftime shows at sports games and other similar events. He wins elections on name recognition regularly in Illinois.

This year, Mr. White decided to retire and is not running for re-election. LP Illinois recruited one of our members, also conveniently named Jesse White, and he is running for Secretary of State as a Libertarian. We may never have an opportunity like this in Illinois again. Our ballot access laws are some of the worst in the country - we need to surpass 5% with a statewide candidate, and the signature thresholds before we gain access are almost impossible to overcome. This is a once in a lifetime opportunity to establish the LP in this state.

In addition to Mr. White, Bill Redpath is our Senate candidate on this ticket. Bill should need no introduction to most of you on the LNC, but for new members, I will simply tell you that Bill is an unmatched ballot access champion. Bill has helped candidates get on the ballot for decades across the country. He regularly travels to other states to help with their volunteer signature efforts. Bill has been ballot access coordinator for the LNC and has been on the LNC's ballot access committee for a number of years. In 2016, he was recognized for his work as he was inducted into the Hall of Liberty alongside Ron Paul (yes, THAT Ron Paul). If for no other reason, Bill deserves the favor repaid.

Finally, we have a full slate of other hard-working candidates as well. Here is the full ticket, presented on one petition as a full statewide slate of Libertarian candidates.

Scott Schluter, Governor John Phillips, Lt. Governor (they are a ticket) Daniel K. Robin, Attorney General Jesse White, Secretary of State Preston Nelson, Treasurer Deirdre McCloskey, Comptroller Bill Redpath, US Senate

If we are successful in getting ballot access this year, we would go at least four years without spending money on Ballot Access in IL again.

I ran for county board in 2018. Because the LP was established in my county, I only needed to get 3 signatures. If the LP had not been established in my county (like in most counties in Illinois), I would have needed 700+ signatures, each from my county board district, roughly a few square miles. That's how extreme ballot access laws are in Illinois. Sure, not having ballot access makes it incredibly difficult for our statewide candidates to get on the ballot, but it also makes it virtually impossible for other Libertarians in Illinois to run in races down the ballot where we have realistic chances at victory.

The Libertarian Party of New Hampshire is writing to you today in regards to financial help with ballot access. Like many other states, we are in the middle of obtaining the required signatures to make sure our candidates will make the ballot in this upcoming election. As if this effort isn't a daunting enough task in and of itself, we have other forces working against us here in New Hampshire. There is a certain member who has considerable out-of-state support who is running "libertarian" candidates in direct opposition to our endorsed candidates in ballot-access races. One can only surmise that this blatant attempt to split our vote is to thwart our chances for obtaining ballot access for the upcoming presidential election cycle. This is something that we would expect from other parties, and to see it occurring within our own party is very disheartening.

The Libertarian Party of New Hampshire is seeking to obtain 5000 signatures, 2500 from each congressional district. We have had the odds stacked against us from the very beginning of this task, since the congressional districts were being reworked. We had no idea how to focus our efforts to maximize our petitioning efforts, but we moved forward regardless of this hurdle. Fortunately, the district map has now been cemented, and we now know where the districts are. The party and campaigns have been organizing volunteer petitioning drives every weekend to obtain the required signatures. In addition we have utilized paid petitioners to help reach our goals. We currently have 1350 signatures in CD1 and 844 in CD2, for a total close to 2200 signatures. LPNH has just authorized the hiring of petitioners to obtain 1700 more signatures, as well as scheduling and running volunteer petition drives every week to meet our goals. It is our hope that we will soon be at the 4000 mark between all efforts. We are seeking the sum of \$5000 to help obtain the remaining 1000 signatures. This will help solidify our ballot access and allow us to redirect our efforts towards campaigning. We will need more time and effort to not only promote our candidates, but also deal with the undermining from bad actors. In the meantime, we will continue our efforts in all of these endeavors. Thank you for considering our request.
